Every entry made on this entry blank shall constitute an agreement and affirmation that all participants (which shall include, without limitation, the owner, lessee, trainer, manager, agent, coach, driver, rider, handler and the horse) for themselves, their principals, representatives, employees of FHANA and the FHANA MARE SHOW EAST and will accept as final the decision of the FHANA hearing committee on any question arising under said rules, and agree to hold NEW YORK STATE FAIRGROUNDS, FHANA, KFPS, their officers, directors and employees harmless for any action taken; and (4) agree that they participate voluntarily in the competition fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death and by participating they expressly assume any and all risks of injury or loss, and they agree to indemnify and hold NEW YORK STATE FAIRGROUNDS & FHANA, KFPS and their officers, directors, employees and agents harmless from and against all claims including for any injury or loss suffered during, or in connection with the competition, whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officers, directors, employees or agents of NEW YORK STATE FAIRGROUNDS, FHANA & KFPS.

By signing below, I consent to authorizing show management to contact the show veterinarian if, in the opinion of show management, the horse has a serious illness or injury and the owner or trainer is not readily available.
